5. Purpose of data processing

The Erasmus+ project ENDORSE (Enhancing development of entrepreneurial strategies at university locations affected by brain drain) aims to strengthen European university locations affected by brain drain by providing a concept to promote entrepreneurial activities for students during and after their studies.

The aim of the present study is to learn more about the entrepreneurial propensity of students, to compare the results internationally and to place them in urban and regional development contexts.

6. Legal basis

The processing is based on the express consent pursuant to Art. 6 sentence 1 lit. a DS-GVO..

7. Personal data

The following categories of personal data are processed:

- Person (gender, age, marital status, place of university entrance qualification, place of residence)
- Study (university, university location, Study field/programme, Semester/Year of study)
- Experience with start-ups (own experience, experience in the family/acquaintances)

8. Recipients of personal data

In addition to the project staff of Hochschule Niederrhein University of Applied Sciences, the project staff of the partner universities (IMC Fachhochschule Krems GmbH, University of Lodz, Mittuniversitetet, Panteion University of Social and Political Sciences, Ventspils University of Applied Sciences) has access to the data. Data protection is ensured by means of a Joint Controller Agreement signed by all project partners.

The transfer of data in project reports, in theses or publications takes place in aggregated form without personal reference.

9. Duration of the storage of personal data

In accordance with good scientific practice, the survey data will be deleted on December 31, 2033. The aggregated survey data have no personal reference.

10. Right of revocation

The declaration of consent can be revoked at any time without giving reasons and without any personal disadvantages. The revocation applies with effect for the future. 11. Data subject rights

According to the General Data Protection Regulation, you have the following rights:

1. If your personal data is processed, you have the right to receive information about the data stored about you. If necessary, you must specify the information or processing operations to which your request for information relates (Art. 15 DS-GVO in conjunction with § 12 DSG NRW). 2.
2. If incorrect personal data is processed, you have the right to rectification (Art. 16 DSGVO).
3. If the legal requirements are met, you can demand deletion, taking into account § 10 DSG NRW (Art. 17 DSGVO).
4. If the legal requirements are met, you can demand the restriction of the processing of the data concerning you (Art. 18 DSGVO).
5. If you have consented to the data processing or a contract for data processing exists and the data processing is carried out with the help of automated procedures, you may have a right to data portability. (Art. 20 DSGVO)
6. The data subject has the right to object at any time, on grounds relating to his or her particular situation, to the processing of personal data concerning him or her carried out on the basis of Article 6(1)(e) or (f) (Article 21 DS-GVO).

If you make use of the aforementioned rights, the person responsible will check whether the legal requirements for this are met.
